# PUBLIC INTEREST LITIGATION ATTORNEY

The Environmental Law & Policy Center (ELPC) is hiring a skilled public interest litigation attorney with 5+ years of litigation experience and, preferably, a background in environmental science, biology, agronomy, soil science, geology or related field. This is a full-time position in ELPC's Chicago HQ office (preferred) or in ELPC's Madison or Grand Rapids offices. This ELPC attorney will focus on litigation and policy advocacy to protect against one of the most pressing threats to safe, clean water in the Midwest: agricultural runoff pollution, particularly from concentrated animal feeding operations (CAFOs), which is fueling hazardous algae blooms and contaminating wells with nitrate, *E. coli* and other contaminants. This is an extraordinary time in which ELPC's effective legal and policy advocacy – backed by sound science, strong economic analysis and public engagement – are essential to protect core environmental values.

#### RESPONSIBILITIES

- Work with ELPC Senior Attorney/Program Lead and ELPC Data Scientist to develop and prosecute legal claims to reduce agricultural runoff pollution that threatens safe, clean water. Litigation could be in federal court, state court, and/or before administrative agencies and include claims under the Clean Water Act, other federal environmental statutes, or state law. Litigation could also include challenges to CAFO permits or interventions in state regulatory proceedings.
- Analyze CAFO regulatory and policy regimes and prepare white papers recommending improvements.





- Review scientific literature on water pollution, agricultural runoff, algae blooms, and related issues for integration into legal and policy advocacy.
- Work with regional and local grassroots allies to advance pollution reduction policies.
- Work effectively in ELPC's public interest multidisciplinary team culture.

#### **QUALIFICATIONS**

- The ideal candidate should have 5+ years of complex litigation experience, preferably in environmental law.
- Excellent writing and persuasive oral advocacy abilities.
- Undergraduate or Master's degree, or equivalent experience, in environmental science, biology, agronomy, soil science, geology or related field strongly preferred.
- Demonstrated commitment to public interest advocacy and the ability to work productively with a team of skilled professionals, including lawyers, scientists, policy and media specialists.
